Trustee's Deed

The GRANTOR, Northwest Trustee Services, Inc., as present Trustee under that Deed of Trust (defined below), in consideration of the premises and payment recited below, hereby grants and conveys, without representation or warranty, expressed or implied, to Raymond James Bank, as GRANTEE, all real property (the Property), situated in the County of SKAGIT, State of Washington, described as follows:

Tax Parcel No.: P68454 and P102255

Parcel "A": Lot 20, "Plat of Rancho San Juan Del Mar, Subd. No. 11", as per Plat recorded in Volume 9 of Plats, Pages 84 and 85, records of Skagit County, Washington. Together with an undivided 1/23rd interest in and to the following described Tract of land for the purpose of giving each owner beach access: The North 26 feet of Lot 1 as measured on the West side thereof, of "Plat of Rancho San Juan Del Mar, Subd. No. 11", as per Plat recorded in Volume 9 of Plats, Pages 84 and 85, records of Skagit County, Washington, except the North 6 feet thereof. Situate in the County of Skagit, State of Washington. Parcel "B": That portion of government Lot 3, Section 11, Township 34 North, Range 1 East, W.M., described as follows: Beginning at the most Southerly corner of Lot 20, "Plat of Rancho San Juan Del Mar, Subd. No. 11", as per Plat recorded in Volume 9 of Plats, Pages 84 and 85, records of Skagit County, Washington; thence North 38 degrees 58'45" West a distance of 122.51 feet to the Northwest corner of said Lot 20 and the true point of beginning; thence continue North 38 degrees 58'45" West to the line of ordinary high tide; thence Northeasterly along the line of ordinary high tide to a point which lies North 38 degrees 58'45" west from the most Northerly corner of said lot 20; thence South 38 degrees 58'45" East to the most Northerly corner of said Lot 20; thence South 50 degrees 13'14" West a distance of 129.64 feet to the true point of beginning. Situate in the County of Skagit, State of Washington.

RECITALS:

1. This conveyance is made pursuant to the powers, including the power of sale, conferred upon the Beneficiary by that certain Deed of Trust between Lynn C King and Meredith J King, husband and wife, as Grantor, to Westward Financial Services, as Trustee, and Mortgage Electronic Registration Systems, Inc. solely as nominee for Horizon Bank, its successors and assigns, Beneficiary, dated 04/17/07, recorded 04/23/07, under Auditor's No. 200704230003, records of SKAGIT County, Washington and subsequently assigned to Raymond James Bank under SKAGIT County Auditor's No. 201210290083.

2. The Deed of Trust was executed to secure, together with other undertakings, the payment of one or more promissory note(s) ("Note") in the sum of \$639,000.00 with interest thereon, according to the terms thereof, in favor of Mortgage Electronic Registration Systems, Inc. solely as nominee for Horizon Bank, its successors and assigns and to secure any other sums of money which might become due and payable under the terms of said Deed of Trust.

3. The Deed of Trust provided that the Property is not used principally for agricultural or farming purposes and the Grantor has no actual knowledge that the Property is used principally for agricultural or farming purposes.

4. Default having occurred in the obligations secured and/or covenants of the Deed of Trust grantor, as set forth in Notice of Trustee's Sale described below, which by the terms of the Deed of Trust make operative the power to sell, the thirty-day advance Notice of Default was transmitted to the Deed of Trust grantor, or his successor in interest, and a copy of said Notice was posted or served in accordance with law.

5. Raymond James Bank, being then the holder of the indebtedness secured by the Deed of Trust, delivered to said Grantor a written request directing Grantor to sell the Property in accordance with law and the terms of the Deed of Trust.

6. The defaults specified in the "Notice of Default" not having been cured, the Grantor, in compliance with the terms of the Deed of Trust, executed and on 02/27/13, recorded in the office of the Auditor of SKAGIT County, Washington, a "Notice of Trustee's Sale" of the Property under Auditor's File No. 201302270159.

7. The Grantor, in the "Notice of Trustee's Sale", fixed the place of sale as inside the main lobby of the Skagit County Courthouse, 205 West Kincaid Street, City of Mount Vernon, State of Washington a public place, at 10:00 AM., and in accordance with the law caused copies of the statutory "Notice of Trustee's Sale" to be transmitted by mail to all persons entitled thereto and either posted or served prior to 90 days before the sale; further, the Grantor caused a copy of said "Notice of Trustee's Sale" to be published in a legal newspaper in each county in which the property or any part thereof is situated, once between the thirty-fifth and twenty-eighth day before the date of sale, and once between the fourteenth and the seventh day before the date of sale; and further, included with the Notice, which was transmitted to or served upon the Deed of Trust grantor or his successor in interest, a "Notice of Foreclosure" in substantially the statutory form, to which copies of the Note and Deed of Trust were attached.

8. During foreclosure, no action by the Beneficiary, its successors or assigns was pending on an obligation secured by the Deed of Trust.

9. All legal requirements and all provisions of said Deed of Trust have been complied with, as to acts to be performed and notices to be given, as provided in chapter 61.24 RCW.

10. The defaults specified in the "Notice of Trustee's Sale" not having been cured ten days prior to the date of Trustee's Sale and said obligation secured by said Deed of Trust remaining unpaid, on September 6, 2013, the date of sale, which was not less than 190 days from the date of default in the obligation secured, the Grantor then and there sold the Property at public auction to said Beneficiary, the highest bidder therefore, for the sum of \$387,000.00. Beneficiary then directed Grantor to issue this Trustee's Deed directly to Grantee.



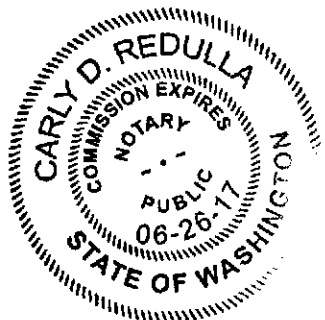


