## MEMORANDUM OF LEASE

(1724 Freeway Drive, Mount Vernon, Washington)

THIS MEMORANDUM OF LEASE ("Memorandum") is made as of Sept (O 2013, by and between Scott Hensrude and Christy Hensrude, husband and wife ("Landlord") and ABRA, Inc., a Minnesota corporation ("Tenant").

## RECITALS

- A. Landlord and Tenant have entered into a Lease dated May 10, 2013 ("Lease"), pursuant to which Landlord has leased to Tenant and Tenant has leased from Landlord the real property located in Skagit County, Washington, that is legally described on Exhibit A attached hereto ("Property").
- B. Landlord and Tenant are executing and recording this Memorandum for the purpose of giving record notice of Tenant's interest in the Property under the Lease.

NOW, THEREFORE, in consideration of the Recitals, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereby agree to the following:

- 1. <u>Lease of Property</u>. Landlord has leased the Property to Tenant in accordance with the terms and conditions contained in the Lease for a term ("Term") that has commenced and expires on May 31, 2023.
- 2. <u>Tenant Extension Options</u>. The Lease grants Tenant the right to extend the Term two (2) times, each such extension being for a period of five (5) years, on terms and conditions set forth in the Lease. If both extension options are exercised and the Lease is not sooner terminated, the Term will expire on May 31, 2033.
- 3. <u>Incorporation of Lease</u>. The Lease contains significant additional provisions. All of the provisions of the Lease are incorporated herein by this reference.

If there is any conflict or inconsistency between this Memorandum and the Lease, the provisions of the Lease shall control.
- 5. <u>Counterparts</u>. This Memorandum may be executed in any number of counterparts, each of which shall be an original and all of which shall be the same document.
