### Memorandum of Lease Termination

THIS MEMORANDUM OF LEASE TERMINATION ("Memorandum") is made as of the 31st day of January, 2013, by and between 100-310 EAST COLLEGE WAY HOLDINGS, LLC, a Maryland limited liability company ("Landlord"), and NEW ALBERTSON'S, INC., an Ohio corporation ("Tenant").

- 1. Landlord, as successor to Skagit Mall 90 Associates, and Tenant, as successor to Albertson's, Inc. entered into that certain Shopping Center Lease dated April 22, 1992, as evidenced by a Memorandum of Shopping Center Lease recorded October 2, 1992, as Auditor's No. 9210020069, Records of Skagit County, Washington, as amendment by letter agreement dated April 22, 1992, Amendment to Shopping Center Lease dated December 21, 1993, recorded February 16, 1994, as Auditor's No. 9402160108, Records of Skagit County, Washington, and Amendment to Shopping Center Lease dated January 18, 2005 (collectively, the "Lease").
- 2. Pursuant to the Lease, Landlord leased to Tenant that certain real property located at 310 East College Way, Mt. Vernon, Washington, as more particularly described in **Exhibit A** attached hereto and made a part hereof.
- 3. Pursuant to the Lease Termination Agreement dated January 28, 2013 ("Termination Agreement"), Landlord and Tenant have agreed to terminate the Lease as of January 31, 2013.
- 4. Upon Tenant's delivery to Landlord of this Memorandum signed by Tenant,
  Landlord shall execute and cause the Memorandum to be recorded in the Records of Skagit
  County, Washington.

- 5. Other provisions regarding the termination of the Lease shall be as provided in the Termination Agreement. In the event of a conflict between the terms hereof and the terms of the Termination Agreement, the Termination Agreement shall control.
- 6. This Memorandum may be executed in any number of counterparts, each of which shall be deemed an original and all of which together shall constitute a single instrument. All the terms, conditions and covenants of the Termination Agreement, which may be inspected at the offices of the Tenant at 250 Parkcenter Blvd., Boise, Idaho 83706, are incorporated herein by this reference.
