Trustee.





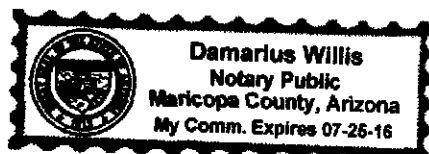
