Number" or "HUN" on Exhibit B) are situated on the real property located within Skagit County, Washington as legally described on Exhibit A to this instrument (the "Property");

TOGETHER WITH the right to harvest and remove the Timber from the Property, and to construct, maintain, and use any roads Grantee deems necessary on the Property for such purposes;

TOGETHER WITH the non-exclusive right to use all of Grantor's access rights and easements that are reasonable and necessary to access and remove the Timber from the Property;
