

As Follows:

Not less than 5 room dwelling of modern new construction to consist of not less than 1200 square feet of habitable floor area on the first floor exclusive of garage. All dwellings or buildings shall be constructed 30 feet or more from front street lines or unless approved by three-fourths of the property owners on the street.

Construction and workmanship to conformity and harmony of external design, with existing structures in Block 4 of this subdivision and as to location of the building with respect to topography and finish ground elevation.

The intention of this covenant is to insure a high quality of design, workmanship and materials to perpetuate the esthetic and monetary values of this area.

Enforcement of covenants shall be by proceedings at law or in equity against any persons violating or attempting to violate any of the covenants.

The validity of any of the covenants shall not be affected by invalidation of any of the others.
