That portion of Government Lot 3, Section 6, Township 35 North, Range 4 East, W.M., lying West of that portion of said Government Lot 3 as deeded to The State of Washington by Warranty Deed dated October 9, 1958, filed in Volume 298 of Deeds, pages 175 and 176, and recorded under Skagit County Auditor's File No. 572316,

EXCEPT that portion, if any, lying within Skagit County Short Plat No. 9-72, approved February 28, 1972,

AND EXCEPT that portion, if any, as condemned by the State of Washington, by Decree entered October 8, 1962 in Superior Court for Skagit County Cause No. 26636,
