The ORDER OF SALE, issued to the Sheriff of Skagit County, Washington, was received by the Sheriff on January 7, 2013, and commanded the Sheriff to cause the amount of the judgment to be made out of the real estate described in the ORDER OF SALE.

The Sheriff did, in obedience to the ORDER OF SALE, levy upon the real property described below, and on February 22, 2013, sold the real property at public auction, for cash in hand, at the front door of the Skagit County Courthouse, 205 W.
