This Memorandum of Lease is related to that certain Restated Lease Agreement ("Lease") dated the 1st day of February, 2014, by and between the Port of Skagit County, a Washington municipal corporation, 15400 Airport Drive, Burlington, Skagit County, Washington as "Lessor" and Tomco Marine Group, Inc., a Washington corporation, 800 E Pearl Jensen Way, La Conner, Skagit County, Washington, as "Lessee."

- 1. <u>Premises Leased</u>. The Lessor has leased to Lessee and Lessee hereby leases from the Lessor, a building and real estate located in Skagit County, Washington, the legal description of which property is described as follows: (See attached Exhibit "A" for legal description and as depicted on Exhibit "B" and Exhibit "C" attached hereto.)
- 2. <u>Term of Lease</u>. The term of this Lease is for eighteen (18) years and two (2) months, commencing on February 1, 2014, and ending March 31, 2032, unless sooner terminated pursuant to any provision of this Lease.
- 3. Extension of Term. The Lease allows Lessee the right to extend this Lease for one (1) ten (10) year option period, subject to certain conditions.
- 4. <u>Early Termination</u>. Lessor grants the Lessee the right to terminate the Lease in the event that the Swinomish Channel becomes non-navigable. For purposes of the Lease, "non-navigable" is defined as the inability, due to the insufficient draft, of a Tomco Marine Group, Inc. manufactured boat of up to fifty-five foot (55') hull length to navigate the Swinomish


Channel from the North and South entrances through the waterway to the La Conner Marina in any tidal conditions for a period of fourteen (14) consecutive days.

5. This Memorandum of Lease is subject to the terms, conditions and restrictions contained in that certain unrecorded Restated Lease Agreement between Lessor and Lessee dated February 1, 2014.


