

5. Property Insurance. Borrower shall keep the improvements now existing or hereafter erected on the Property insured against loss by fire, hazards included within the term "extended coverage," and any other hazards including, but not limited to, earthquakes and floods, for which Lender requires insurance. will begin when the notice is given. - 12. Borrower Not Released; Forbearance By Lender Not a Waiver.
