As of May 12, 2014, there is an outstanding balance of \$3,507.00 due and owing in connection with the following property at Skagit Highlands:



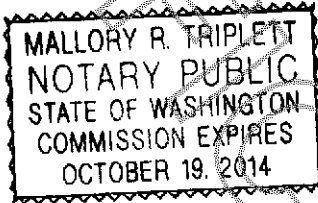
