THE GRANTOR, REGIONAL TRUSTEE SERVICES CORPORATION, as present Trustee under that Deed of Trust, as hereinafter particularly described, in consideration of the premises and payment, recited below, hereby grants and conveys without warranty, to: U.S. Bank Trust, N.A., as Trustee for LSF8 Master Participation Trust, GRANTEE, that real property, situated in the County of SKAGIT, State of WASHINGTON, described as follows:

RECITALS:

- 1. This conveyance is made pursuant to the powers, including the power of sale, conferred upon said Trustee by that certain Deed of Trust dated 9/26/2006, recorded in Auditor's/Recorder's No. 200609290307, records of SKAGIT County, Washington, from JOSE M. GONZALEZ, AN UNMARRIED MAN AND MARIA VICTORIA AYON NUNEZ, AN UNMARRIED WOMAN, as Grantor, to FIRST AMERICAN TITLE, as Trustee, in favor of MORTGAGE ELECTRONIC REGISTRATION SYSTEMS, INC. AS NOMINEE FOR ACCREDITED HOME LENDERS, INC. A CALIFORNIA CORPORATION ITS SUCCESSORS AND ASSIGNS, as Beneficiary.
