4	3.1 Plaintiff's lien shall be a first and prior lien upon the following-described real property,
5	superior to any right, title, claim, lien or interest on the part of the Defendants or persons claiming by, through or under the Defendants:
6	Lot 63, "PLAT OF KLINGER ESTATES", as per the plat thereof recorded on May 8 th , 2006, under Auditor's File No. 200605080213, records of Skagit County, Wash.

8 9	3.2 The lien described herein shall be foreclosed and the said real property shall be sold in one or more parcels in accordance with and in the manner provided by law.
10	3.3 Plaintiff shall be permitted to be a purchaser at the sale; that the net proceeds of said sale
11	be applied first toward the payment of the costs of said sale and then towards the payment of Plaintiff's judgment
12	3.4 Plaintiff shall have and retain a deficiency judgment against Defendant Berrington, in the
13	event that the bid(s) at the sale(s) are less than the sum of Plaintiff's entire judgment, plus the costs of sale, provided that no judgment shall so enter for any amounts rendered uncollectible by operation of the United States bankruptcy laws.
