The temporary rights herein granted shall terminate six (6) months from commencement of construction on this parcel or December 31, 2016, whichever date occurs first.

#### EXHIBIT A

All that portion of the following described PARCEL "A" lying within a tract of land beginning at a point opposite Highway Engineer's Station (herein referred to as HES) H 22+24.71 on the H line survey of City of Mount Vernon Siding Extension-Road Improvements, Hickox Road and 30 feet northerly therefrom;

thence along a curve to the right having a radius of 47.50 feet for an arc distance of 79.31 feet to a point opposite HES H 22+95.13 on said line survey and 30 feet northerly therefrom;

thence easterly parallel with said line survey to a point opposite HES H 23+00.00 thereon; thence northerly to a point opposite said HES H 23+00.00 and 70 feet northerly therefrom; thence westerly parallel with said line survey to a point opposite HES H 22+00.00 thereon; thence southerly to a point opposite said HES H 22+00.00 and 30 feet northerly therefrom; thence easterly parallel with said line survey to the Point of Beginning.
