PARCEL "B":

That portion of the West ½ of Section 27, Township 35 North, Range I East, W.M., described as follows:

Beginning at the Northwest corner of Lot 4, "SKYLINE NO. 11," as per plat recorded in Volume 9 of Plats, pages 78 and 79, records of Skagit County, Washington;

thence North 50°32'20" West 95.00 feet from which point the center of a curve bears North 50°32'20" West a distance of 60.00 feet;

thence Northerly 17.21 feet along the arc of said curvature having a central angle of 16°26'11"; thence South 66°58'31" East 95.00 feet to the Northeast corner of said Lot 4;

thence Southerly 44.47 feet along the arc of aforementioned curvature having a radius of 155.00 feet and a central angle of 16°26'11" to the point of beginning;
