- 1. **GRANTOR**. The undersigned Grantor, Edmond Gallegos, is the duly appointed, qualified and acting personal representative of the Estate of ELISABETH SIPMA, deceased.
- 2. **ESTATE**. Elisabeth Sipma, ak.a. Betty Sipma died on April 27, 2014. On May 16, 2014 the Will of Elisabeth Sipma dated November 16, 2007 was admitted to probate and Grantor was appointed personal representative in the State of Washington Superior Court of Skagit County in Cause No. 14-4-00176-2.
- 3. **NONINTERVENTION POWERS**. By Order of Solvency entered on May 16, 2014 in the Probate Proceedings, Grantor was authorized to settle the Estate without further court intervention or supervision.
