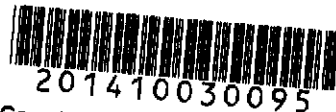
IX.

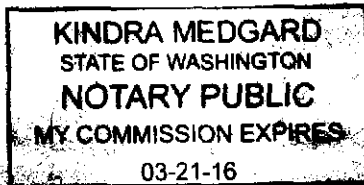
