THE GRANTOR, The Swinomish Indian Tribal Community, for and in consideration of ONE DOLLAR AND OTHER GOOD AND VALUABLE CONSIDERATION in hand paid, conveys and warrants to THE UNITED STATES OF AMERICA IN TRUST FOR THE SWINOMISH INDIAN TRIBAL COMMUNITY, the following described real estate, situate in the County of Skagit, State of Washington:

The rights of way of the following portions of or appurtenances to State Highway Route 20: Those portions of Government Lots 4 and 5 of Section 2, Township 34 North, Range 2 East, W.M., lying within the former right of way of State Highway Route No. 20, shown hatched on Exhibit "A-2", being sheets 3 and 4 of that certain plan entitled "SR 20, March Point Rd. to Fredonia", attached hereto and by this reference made a part thereof.

Subject to conditions and reservations contained in the Quit Claim Deed recorded May 18, 1984, under Auditor's File No. 8405180020, records of Skagit County, Washington.

Title to the land herein described shall be subject to any existing easements for public roads and highway, for public utilities and for railroads and pipelines and any other rights of way of record.

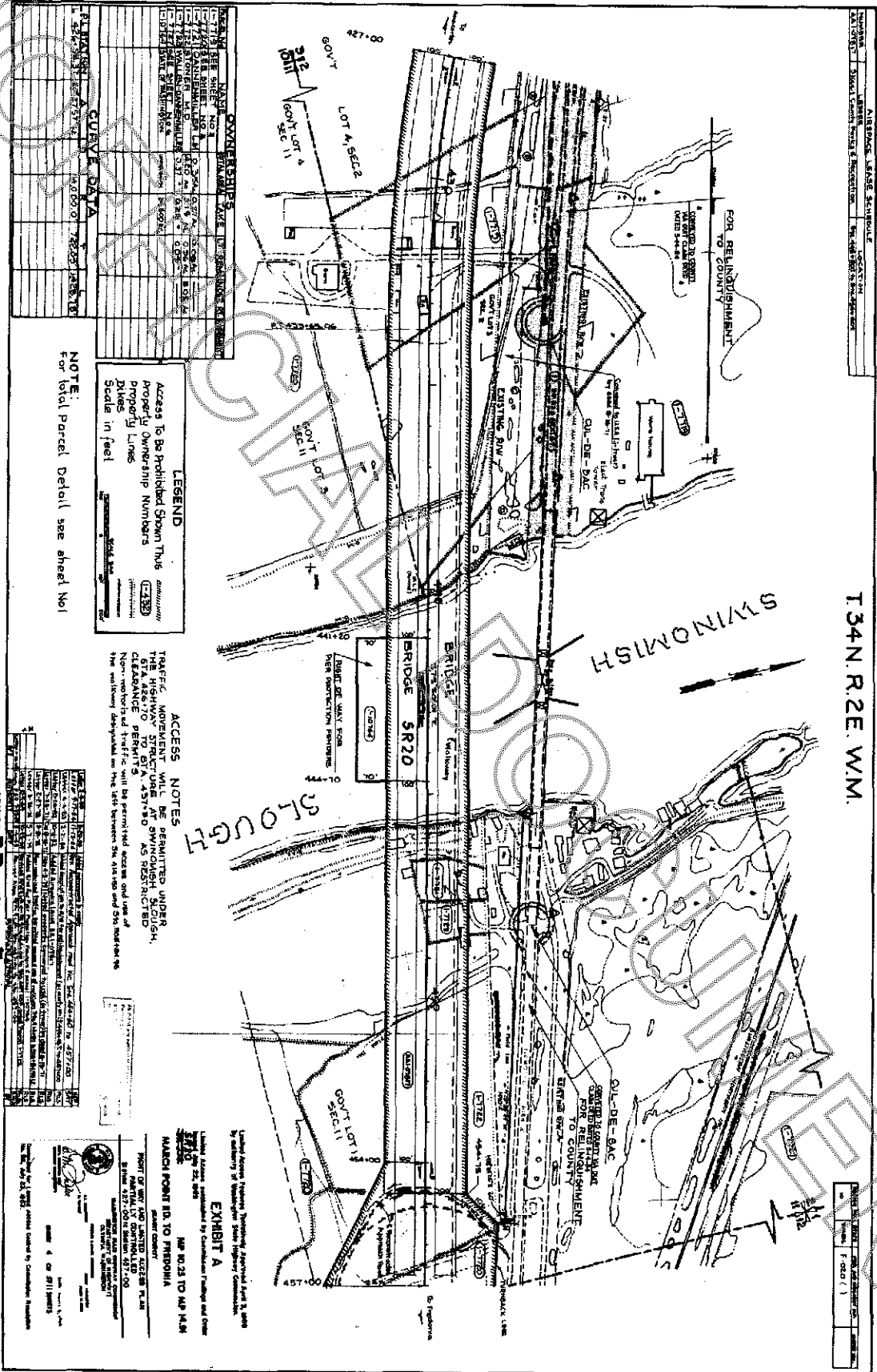
