## AMENDMENT TO RESTRICTIONS AND PROTECTIVE COVENANTS FOR REAL PROPERTY KNOWN AS EAGLES CROSSING SHORT PLAT NO. PL07-0578, LOT 1, LOT 2, LOT 3 AND LOT 4

THIS AMENDMENT is made this 15th day of October, 2014, by THE COMMITTEE FOR EAGLES CROSSING SHORT PLAT NO. PL07-0578, ("Declarant")

This document amends the Restrictions and Protective Covenants for Eagles Crossing, Short Plat No. PL07-0578, recorded September 29, 2008, under Skagit County Auditor File No. 200809290184, records of Skagit County, Washington (the "Covenants"), and affects property legally described as follows:

The southeast quarter of the southwest quarter and the east 468.34 feet of the south half of the southwest quarter of the southwest quarter, EXCEPT the south 42 feet thereof as conveyed to ABC Investments by deed recorded June 26, 1985, under Auditor's File No. 8506260027, records of Skagit County, Washington, all in Section 1, Township 35 North, Range 1 East, W.M.

Situate in the County of Skagit, State of Washington

The amendments contained in this document were put to a vote of the Committee of Eagles Crossings ("Committee"). These amendments passed by a vote of not less than seventy-five (75%) percent of Committee members pursuant to and in compliance with Section 2 of the Covenants.

NOW, THEREFORE, the Committee of Eagles Crossing hereby amends the Covenants as to Sections 6, 8, 10, 14, 16 and 20. These Sections are amended in their entirety and shall be deleted and the following inserted in their place:
