EXHIBIT A

That portion of Skagit County Short Plat 93-073, approved October 25th, 1993 and recorded October 26th, 1993, under Auditor's File No. 9310260063, in Volume 11 of Short Plats, pages 6 and 7, described as follows:

Beginning at the Southeast corner of the said Lot 1; thence West along the South line of the said Lot 1 a distance of 93.71 feet, more or less, to the Southeast corner of that portion thereof conveyed to Pamela L. Hom by deed recorded as Auditor's File No. 200007060005; thence North along the East line of the said Hom parcel a distance of 35 feet to the Northeast corner thereof; thence East parallel with the South line of the said Lot 1 to the East line thereof; thence South to the Point of Beginning.

TOGETHER WITH a non-exclusive easement to use the existing well for the benefit of Lot 2, which well is located approximately as delineated on the face of the said Short Plat.

AND TOGETHER WITH a non exclusive easement to use the existing waterline running from said well to the Northerly line of the tract conveyed to Hom by AFN 200007060005, which waterline is described as follows: Beginning at the well; thence Southwesterly, roughly parallel with the Northwesterly line of the existing house on the said Lot 1 as delineated on the face of the Short Plat to a point just past the Westerlymost corner of the concrete slab as delineated on the face of the said Short Plat at the Westerlymost corner of the said house; thence Southeasterly to the Northerly line of the said Hom tract.

All of the above being a portion of the West 1/2 of the Southeast 1/4 of Section 5, Township 33 North, Range 4 East, W.M.
