 Instruments, as charged in Count 19 of the Second Superseding Indictment, in violation

 described property is subject to forfeiture.

Pursuant to Title 21, United States Code, Section 853(n), the United States
published notice on an official internet government forfeiture website,

8 www.forfeiture.gov, starting on February 7, 2014 and running consecutively for thirty 9 days until its conclusion on March 8, 2014. In the publication, the United States 10published notice of the Preliminary Order of Forfeiture and the intent of the United States 11 to dispose of the property in accordance with law. This notice further stated that any person other than the defendant having or claiming an interest in the property was 12 required to file a petition with the Court within sixty (60) days of the first date of 13 publication of the notice, setting forth the nature of the petitioner's right, title, and 14 15 interest in the property.

On March 11, 2104, and March 27, 2014, the United States sent notice of the
Preliminary Order of Forfeiture filed against the Wilburs, via certified mail, to Laura B.
Beard, Lenora F. Wilbur, Cook, Randall Cook, Fidalgo Bay Cigar Company, LLC, Salish
Trust, Skagit Cigarette Sales Trust, Skagit State Bank.

20On April 4, 2014, the Skagit State Bank filed a Motion to Adjudicate Its Interest in21the property subject to forfeiture.

On July 11, 2014, this Court approved the Stipulated Settlement Agreement
between the United States and Skagit Bank, in which the United States recognized
Petitioner Skagit's Bank's interest in a portion of the currency seized from the Wilburs,
\$8,042.29, and the real property known as Skagit County Parcel No. P59700.

All persons and entities believed to have an interest in the property subject to
forfeiture were given proper notice of the intended forfeiture.
