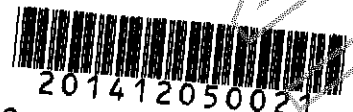
IX.

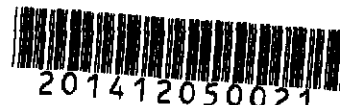
