WHEREAS, the parties agree and seek to establish an arrangement whereby the owners of P49915 and P49925 enjoy equal rights to make use of the Water system and share on an equitable basis, the costs associated with operating and maintaining the Water system.


WITNESSETH:

Cost of Maintenance, Repairs, and Improvements: The owners and their respective successors, heirs, and assigns of P49915 and P49925 shall each bear and be responsible for one half of the cost of operating and maintaining the Water system, including the cost of the electricity. The Water system shall, at all times be maintained in good and serviceable condition. The owners of P49915 and P49925 shall share equally in the cost of insuring that the Water system complies, at all times, with all applicable laws, ordinances, rules, and regulations promulgated by federal, state, and local agencies, including but not limited to those relating to water quality standards.
