That portion of Lots 53 and 63, Plat 1, "LAKEVIEW TRACTS, BIG LAKE, SKAGIT CO., WASH," as per plat recorded in Volume 5 of Plats, pages 2 and 3, records of Skagit County, Washington, and vacated LAKEVIEW BOULEVARD adjoining said Lots 53 and 63, said portion being described as follows:

Beginning at the Southwesterly corner of said Lot 63 (also the Northwesterly corner of Lot 56 as shown on that Boundary Line Adjustment Survey recorded under Auditor's File Number 200302130117, records of Skagit County, Washington), said point also being on the Easterly margin of West Big Lake Boulevard and being a point on a curve concave to the West;

thence Northerly along said margin and the arc of said curve to the left having an initial tangent bearing of North 01°32'45" East and a radius of 412.45 feet, through a central angle of 12°11'10", an arc length of 87.72 feet to a point of tangency;
