# Exhibit A to Memorandum of Lease

### Description of Premises

Lot 2, BURLENGTON BINDING SITE PLAT NO. 2-97, approved July 14, 1997, recorded December 18, 1997, under Auditor's File No. 9712180060, filed in Volume 13 of Short Plats, pages 67 and 68, being a portion of the Southwest Quarter of the Southwest Quarter of Section 5, Township 34 North, Range 4 East of the Willamette Meridian, more particularly described as follows:
