MEMORANDUM OF LEASE (Burlington, Washington)

THIS MEMORANDUM OF LEASE is made as of February 2, 2014 by and between HEALTH CARE REIT, INC., a corporation organized under the laws of the State of Delaware, HCRI NEVADA PROPERTIES, INC., a corporation organized under the laws of the State of Nevada, and 1111 W. COLLEGE PARKWAY, LLC, a limited liability company organized under the laws of the State of Delaware (collectively, the "Landlord"), and STANLEY & SHORTEN, LLC, a limited liability company organized under the laws of the State of Washington (the "Tenant").

- 1. Lease.
