THIS AGREEMENT is made by and among FORTUNA PROPERTIES, LLC, a Washington limited liability company, (hereinafter "Landlord") and ANDERSON APPLIANCE SERVICES, INC., a Washington corporation (hereinafter "Tenant"), and the U. S. SMALL BUSINESS ADMINISTRATION, an agency of the United States of America (hereinafter "Assignee").

RECITALS

- A. Landlord leased to Tenant the real property legally described as set forth below and commonly known as 2520 Cedardale Road, Mount Vernon, Washington 98274, pursuant to a lease (the "Lease Agreement"), a Memorandum of which was recorded on June 16, 2005 under Skagit County Auditor's File No. 200506160112.
- B. The Lease Agreement was assigned to Northwest Business Development Association by an Assignment of Leases and Cash Collateral recorded on June 16, 2005 under Skagit County Auditor's File No. 200506160113, which Assignment was subsequently assigned to the U. S. Small Business Administration pursuant to an Assignment of Assignment of Leases and Cash Collateral recorded on June 16, 2005 under Skagit County Auditor's File No. 200506160114, which Assignment of Assignment of Leases and Cash Collateral was re-recorded on June 17, 2005 under Skagit County Auditor's File No. 200506170154 (the "Lease Assignments").
- C. All parties hereto have agreed that the Lease Agreement which commenced April 15, 2005 has been terminated effective as of November 30, 2011.
- D. The real property that is the subject of the Lease Agreement and the Lease Assignments is more particularly described as:

Lot 4 of Binding Site Plan No. PL03-0071, recorded May 7, 2003, under Auditor's File No. 200305070015, records of Skagit County, Washington, and being a portion of the Southeast $\frac{1}{4}$ of the Southwest $\frac{1}{4}$ of Section 29, Township 34 North, Range 4 East, W.M.

TOGETHER WITH a perpetual exclusive easement for the purposes of installing, maintaining and repairing a sign as conveyed by Easement Deed recorded March 3, 2005, under Auditor's File No. 200503030054.

AND ALSO TOGETHER WITH that portion of Tract A of Binding Site Plan No. PL03-0071, recorded May 7, 2003, under Auditor's File No. 200305070015, records of Skagit County, Washington, and being a portion of the Southeast $\frac{1}{4}$ of the Southwest $\frac{1}{4}$ of Section 29, Township 34 North, Range 4 East, W.M., lying East of the East line of Lot 1 of said Binding Site Plan and West of the East line of Lot 4 of said Binding Site Plan, extended South to the South line of said Tract A.

Situate in the County of Skagit, State of Washington.



NOW THEREFORE, in consideration of the promises and of the agreements contained in this Agreement, the parties agree as follows:

1. That the Lease Agreement which commenced on April 15, 2005 from the Landlord to Tenant, the Landlord's interest in which was subsequently assigned to the U. S. Small Business Administration, is hereby mutually terminated effective as of November 30, 2011 and the parties to the Lease Agreement have no further right or obligation arising from or relating to the Lease Agreement.
2. That the Lease Assignments secured indebtedness owed to Assignee which debt has been paid in full. The Lease Assignments currently held by the U. S. Small Business Administration, are hereby terminated effective immediately and the parties to the Lease Assignments have no further right or obligation arising from or relating to the Lease Assignments.

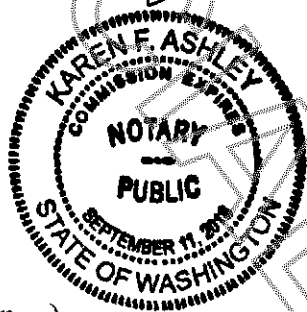

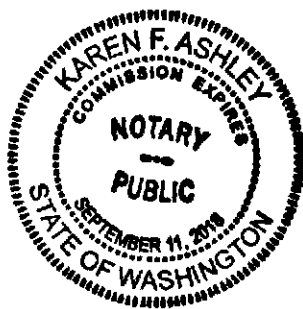

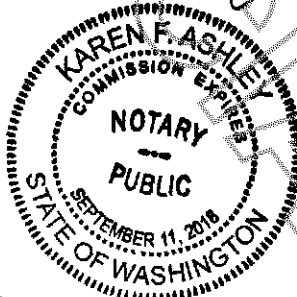
