- 1. **GRANTOR; NONINTERVENTION POWERS.** The undersigned Grantor, Diane E. Berg, is the duly appointed, qualified and acting Personal Representative of the Estate of Donald L. Berg (the "Estate"). Donald L. Berg (the "Decedent") died on February 6, 2014. Grantor was appointed Personal Representative of the Estate on March 18, 2014 in the Superior Court of the State of Washington for King County Case No. 14-4-01693-7 SEA (the "Probate Proceedings"). By Order of Solvency entered on March 18, 2014, in the Probate Proceedings, Grantor was authorized to settle the Estate without further court intervention or supervision.
