

Judgment in Favor of Oceanside and Against Defendant Dennis R. Cook on Count
I of the Complaint, IT IS HEREBY ORDERED, ADJUDGED AND DECREED
that:

- 1. Final judgment is entered in favor of Plaintiff, 1250 OCEANSIDE, LLC, formerly known as 1250 OCEANSIDE PARTNERS ("Oceanside") and against Dennis R. Cook, on Count I of the Complaint, in the amount of \$421,194.86 (the "Judgment Amount").
- 2. Post-judgment interest shall accrue on the Judgment Amount from the date of judgment, at the federal post-judgment interest rate of 0.14% per annum.
- 3. Defendant Sun Kona Finance II, LLC ("SKF II""), or an entity designated by SKF II, has rights with respect to the Judgment Amount, as set forth in that certain Order Granting Motion for Approval of Stipulation and Order re Carryback Mortgages, in Oceanside's main bankruptcy proceeding, at Docket No. 260.
- 4. This judgment shall be final pursuant to Fed. R. Civ. P. 54(b) and Fed. R. Bankr. P. 7054.
