Skagit County has established natural resource management operations as a priority use on designated Natural Resource trands, and area residents should be prepared to accept such incompatibilities, inconveniences or discomfort from normal, necessary Natural Resource Land operations when perfermed in compliance with Best Management Practices and local, State, and Follershay.

In the case of mineral lands, application might be made for mining-related activities including extraction, washing, crushing, stockpiling, blasting, transporting and recycling of minerals. If you are adjacent to designated Nil Lands, you will have setback requirements from designated NR Lands.
