# COLLEEN R. HAYS REVOCABLE LIVING TRUST

THIS AMENDED AND RESTATED TRUST AGREEMENT (the "Trust Agreement") is made and entered into on the 25<sup>th</sup> day of the day o

## ARTICLE I

## Recitals

1.01 Family. Settler is married to GEORGE J. SIMCHUK as of April 18, 2009. She has two children: JENNIFER KATHLEEN HAYS (FORMERLY ZUNIGA), born November 26, 1975; and JONATHAN FRANKLIN HAYS, born September 8, 1982. Settler's son, David, died without descendants. Settler has no other children, nor any deceased children who have surviving descendants. GEORGE J. SIMCHUK has two (2) adult children form a previous marriage; ERIK J. SIMCHUK and MARK L. SIMCHUK.

1.02 Status of Property. Settlor hereby declares and confirms that all of her property is separate property WITH THE EXCEPTION of a single family residence at 621 Ames Way, Dover ID 83825. This property is held jointly with her husband. It is Settlor's intention that all property transferred in trust and the proceeds thereof shall retain its character as separate property, and that her investment in the property at 621 Ames Way, Dover ID 83825 be characterized as joint property.

1.03 Trust Name. The name of this Trust shall be the "Colleen R. Hays Revocable Living Trust."

1.04 <u>Trust History.</u> Settlor formed the Trust by Trust Agreement dated September 28, 2001. Exercising the power of amendment reserved at Article III. Section 3.01.B of the Trust Agreement, Settlor amended and restated the Trust Agreement in its entirety by trust Agreement dated January 11, 2007 and again on April 13, 2009. Exercising the power of amendment reserved at Article III, Section 3.01.B of the Trust Agreement, Settlor is hereby amending and restating the Trust Agreement in its entirety.

## ARTICLE II

## Trust Estate

The "trust estate" as that term is used in this instrument shall consist of all of the following:

2.01 <u>Initial Trust Estate</u>. The initial trust estate shall consist of the assets described in the attached Schedule I, which assets have been and are further, by this declaration, hereby transferred to the trustee, who acknowledges their receipt, and agrees to hold them in trust pursuant to the terms of this Agreement.

5.05 Waiver of Confidentiality. Settlor hereby waives on behalf of herself for the benefit of the Trustee all provisions of law relating to the disclosure of confidential medical information, and Settlor directs any physician, hospital or other person requested by the Trustee to disclose complete information as to all medical findings and treatment administered to Settlor, without limitation. Settlor, as both Settlor and Trustee, authorizes and requests any physician, health care professional, health care provider and medical care facility to provide any successor trustee identified in or in accordance with the procedure set forth in this Trust Agreement information relating to Settlor's physical and mental condition and the diagnosis, prognosis, care and treatment thereof upon the request of successor trustee. It is Settlor's intent by this authorization for the successor trustee to be considered a personal representative under privacy regulations related to protected health information and for the successor trustee to be entitled to all health information in the same manner as if the Settlor was personally making the request. This authorization and request shall also be considered a consent to the release of such information under current laws, rules and regulations as well as under future laws, rules and regulations and amendments to such laws, rules and regulations to include but not be limited to the express grant of authority to personal representatives as provided by Regulation Section 164.502(g) of Title 45 of the Code of Federal Regulations and the medical information privacy law and regulations generally referred at as the Health Insurance Portability and Accountability Act of 1996 (HIPAA).

## ARTICLE VI

### Trustees

- 6.01 <u>Selection of Trustees</u>. The Settlor shall serve as the initial trustee of this Trust. If the Settlor is unwilling or unable to serve as trustee, JENNIFER K. HAYS, JONATHAN F. HAYS and BRENT K. EGLE shall serve as co-successor trustees. If any of JENNIFER K. HAYS, JONATHAN F. HAYS and BRENT K. EGLE is unable or unwilling to serve as trustee, then DALE P. SANGER shall serve as co-trustee.
- 6.02 <u>Trustees' Appointment of Additional or Successor Trustees</u>. Trustee(s) may, from time-to-time, by written instrument filed with the trust records, appoint one (1) or more additional or successor trustees, or a future trustee to become acting upon any stated contingency and may, by a similar instrument, revoke the appointment of any future trustee at any time before the occurrence of any such contingency. Any such trustee may be appointed with limited powers and responsibilities delegated pursuant to Section 6.13.H, below.
