THAT PORTION OF THE SOUTHEAST QUARTER OF THE SOUTHEAST QUARTER OF SECTION 24, TOWNSHIP 35 NORTH RANGE LEAST OF THE WILLAMETTE MERIDIAN, DESCRIBED AS FOLLOWS:

COMMENCING AT A POINT ON THE SOUTH LINE OF SAID SECTION, 640.2 FEET WEST OF THE SOUTHEAST CORNER OF SAID SECTION,

THENCE NORTH TO THE NORTH LINE OF 29TH STREET, PRODUCED, TO THE TRUE POINT OF BEGINNING; THENCE NORTH 110 FEET;
