


#### MASTER FORM DEED OF TRUST

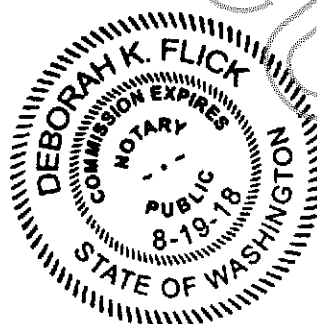
