- DESCRIPTION OF PREMISES. Landlord hereby leases to Tenant real property containing approximately Twenty Thousand (20,000) Leasable Square Feet (Dimensions 160' frontage x 118' depth) located in the City of Burlington, County of Skagit, State of Washington and constructed on land described in Exhibit A attached hereto.
- 4. INITIAL TERM OF LEASE. The Initial Term of the Lease is lifteen (15) years.
- OPTIONS TO EXTEND. The Lease grants to Tenant successive options to extend the Lease Term from the date upon which the Lease Term would otherwise expire for Six (6) additional consecutive periods of Five (5) years each.
