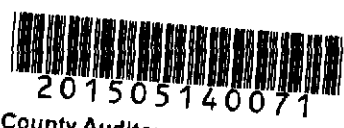

As of May 8, 2015, there is an outstanding balance of \$968.00 due and owing in connection with the following property at Skagit Highlands:



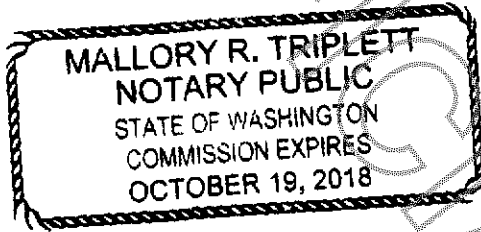
