THIS IS A MEMORANDUM OF EXTENSION OF LEASE executed this April, 2015, between ANACORTES CONCEPT, LLC, a Washington limited liability company, and RYAY, LLC, a Washington limited liability company (collectively "Landlord"), and THRIVE COMMUNITY FITNESS ANACORTES, LLC, a Washington limited liability company ("Tenant").

- Purpose: The parties execute this Memorandum of Extension of Lease for recording purposes only.
- Incorporation by Reference: The parties incorporate herein by reference that certain Initial Lease Agreement dated November 15, 2015, and the Extension of Lease of even date herewith.
  - 3. Term under Initial Lease Agreement. The term under the Initial Lease Agreement

- Termination of Rights under Initial Lease Agreement. The Tenant's Option to Purchase under the Initial Lease Agreement has been terminated and is of no further force and effect.
- 6. Modification of First Right to Purchase. The Tenant's first right to purchase under Section 25 of the Initial Lease Agreement has been modified such that "third party" as used in Section 25 and subparagraphs therein shall not apply to sales or transfers between Anacortes Concept, LLC, and RYAY, LLC.


