HENDRICKSON, not personally but as Successor Trustee of THE HENDRICKSON FAMILY TRUST, DATED August 2, 1995, is the Grantor, and SKAGIT STATE BANK, now SKAGIT BANK, is the Lender, describing land therein as follows:

Tracts 21 and 22 of "WEST VIEW REPLAT OF BLOCK 40, MONTBORNE, SKAGIT COUNTY, WASHINGTON," as per plat recorded in Volume 6 of Plats, page 5, records of Skagit County, Washington.
