SECOND AMENDMENT TO DEED OF TRUST

This Second Amendment to Deed of Trust (this "Amendment"), dated as of May 29, 2015, is made with respect to that certain Deed of Trust, Assignment of Rents and Leases, Security Agreement and Fixture Filing made on or about October 10, 2013, and recorded October 10, 2013 under Skagit County Recording No. 201310100069 (as amended from time to time, the "Deed of Trust"), granted by COASTAL FARM REAL ESTATE, INC., an Oregon corporation, as Grantor, for the benefit of U.S. BANK NATIONAL ASSOCIATION, as Beneficiary. As used herein, capitalized terms shall have the meanings given to them in the Deed of Trust, except as otherwise defined herein, or as the context otherwise requires.

AGREEMENT

IT IS HEREBY AGREED AS FOLLOWS:

- 1. The Deed of Trust is hereby amended to reflect that the Credit Agreement has been amended by that certain Second Amendment to Amended and Restated Credit Agreement of even date herewith between Borrower and Beneficiary, whereby among other things, Beneficiary increased the commitment amount of the revolving loan from \$28,000,000 to \$32,000,000, as such amount may be further increased up to \$42,000,000 upon satisfaction of certain conditions, and such increased amounts under the revolving loan shall be deemed a Secured Obligation under the Deed of Trust.
- 2. Section 1 of the section of the Deed of Trust titled "TO SECURE THE FOLLOWING ("Secured Obligations") is hereby amended in its entirety to read as follows:
 - (1) Payment of the sum of (a) up to FORTY-TWO MILLION and NO/100 (\$42,000,000.00), according to the terms and provisions of a Renewal Revolving Note A dated as of May 29, 2015, made by Borrower and payable to Beneficiary and (b) TWENTY FIVE MILLION and NO/100 (\$25,000,000.00), with interest thereon, according to the terms and provisions of a Term Note dated as of February 28, 2014, made by Borrower and payable to Beneficiary (each individually and collectively referred to as, the "Note").
- 3. Except as provided herein, the Deed of Trust remains unmodified and the parties ratify and confirm all terms, covenants and provisions thereof.
- 4. This Amendment may be executed in one or more counterparts, each of which shall constitute an original agreement, but all of which together shall constitute one and the same agreement.
