B. The purpose of this easement agreement is to provide for an utility easement for the installation, operation and maintenance of utilities, over, across and through the area described within the accompanying Exhibit A and mapped within Exhibit B for the benefit of the Grantees upon the terms and conditions set forth in this Utility Easement Agreement, hereinafter also referred to as 'Easement' or 'Easement Agreement'.

EASEMENT AGREEMENT:

THEREFORE, in consideration of the mutual covenants and agreements herein contained, the receipt and sufficiency of which consideration is hereby acknowledged, effective as of the date written below, the parties agree as follows:

1. The Recitals set forth above are hereby fully incorporated herein by this reference.

2. Grant of Easement:

a. The Grantors Larry J. Quesnell, Charles M. and Susan G. Drackett, Jay H. and Nanci C. Overway, David E. and Jean R. Christensen, and Angela M. Meyer do hereby grant and convey to the Grantees, Arthur D. and Vickie S. Jensen, a perpetual, non-exclusive easement for utilities over, across and through the portions of their property that is described within the attached Exhibit A, and mapped on the attached Exhibit B.

3. Use, Maintenance and Repair of Easement Area:

- a. None of the parties may unreasonably interfere with the use of the easement for utility installation, operation, and maintenance by the others.
- b. Each party shall, at their sole cost and expense, have the obligation to maintain their utility improvements located within the easement area (described and mapped in the accompanying Exhibits A and B).
- 4. The failure of a party to this Easement to insist upon the performance of any of the terms and conditions of this Easement shall not be construed as thereafter waiving any such terms and conditions, but the same shall continue and remain in full force as if no such forbearance or waiver had occurred.
- 5. The Grantees shall hold the Grantors harmless from and against all claims for damages arising out of the use of the easement granted herein.
- 6. **Duration.** This Easement Agreement shall be perpetual in duration and shall run with the land, and shall be binding on the undersigned and all successors, assignees, devisees, and/;or transferees of the parties and shall, in all respects, attach to the individual properties legally described in this Easement Agreement.
- 7. Governing Law and Venue. This Easement Agreement shall be construed under the laws of the State of Washington. It is agreed by the parties that the venue for any legal action brought under or relating to the term of this agreement shall be in Skagit County, State of Washington.
- 8. Severability. Should any term or provision of this Easement Agreement, as set forth herein, be found to be void or unenforceable by a court of competent jurisdictions, all other terms and provisions of this agreement shall remain enforceable, binding, and in full force and effect.

LEGAL DESCRIPTION FOR ART AND VICKI JENSEN OF UTILITY EASEMENT



An easement for installation, operation and maintenance of utilities, over, across and through that portion of the south half of the southwest quarter of Section 32, Township 35 North, Range 3 East, W.M., described as follows:

Beginning at the southwest corner of Lot 2 of Short Plat #PL05-0109 as recorded under AF#200511180020, records of Skagit County, Washington,; thence S 89°48′13″W along the south line of said Short Plat and the westerly prolongation thereof, a distance of 627.93 feet to the easterly line of Bayview-Edison Road; thence N 28°49′22″W, along said easterly line, a distance of 68.36 feet to the north line of Starvation Ridge Lane as shown on said Short Plat #PL05-0109; thence N 89°48′13″E along the northerly line of said Starvation Ridge Lane and the easterly prolongation thereof, a distance of 687.19 feet to the easterly line of said Starvation Ridge Lane; thence S 1°14′12″W along the easterly line of said Starvation Ridge Lane, a distance of 35.84 feet; thence S 58°02′18″E, a distance of 45.41 feet to a point on the south line of Lot 2 of said Short Plat #PL05-0109; thence S 89°48′13″W, a distance of 64.05 feet to the point of beginning.
