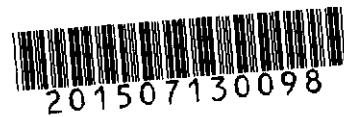

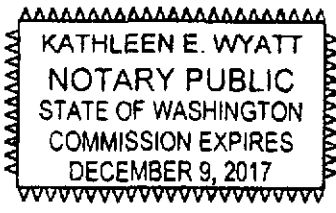

## EXHIBIT A

### PARCEL "A":

That portion of the Northeast  $\frac{1}{4}$  of the Southwest  $\frac{1}{4}$  of Section 32, Township 34 North, Range 4 East, W.M., described as follows:

Beginning at a point 1,973 feet North of the Southwest corner of the Southeast  $\frac{1}{4}$  of the Southwest  $\frac{1}{4}$  of said Section;  
thence North 197 feet, more or less, to a point 470 feet South of the Northwest corner of said Northeast  $\frac{1}{4}$  of the Southwest  $\frac{1}{4}$ ;  
thence East to center of slough;  
thence in a Southwesterly direction down center of said slough to a point due East of beginning;  
thence West to beginning.

EXCEPT the West 16 feet for road,

AND EXCEPT drainage ditch rights of way.

AND EXCEPT those portions conveyed to the State of Washington by Deeds recorded under Auditor's File Nos. 537748 and 754330.

ALSO, that portion of the Northeast  $\frac{1}{4}$  of the Southwest  $\frac{1}{4}$  of Section 32, Township 34 North, Range 4 East, W.M., described as follows:

Beginning at a point on the South line of the North  $\frac{1}{2}$  of the Northeast  $\frac{1}{4}$  of the Southwest  $\frac{1}{4}$  of said Section 32, a distance of 396 feet West of the Southeast corner thereof;  
thence Northerly along a straight line, that if projected would intersect the North line of said Northeast  $\frac{1}{4}$  of the Southwest  $\frac{1}{4}$  at a point 315 feet West of the Northeast corner thereof, to a point due East of a point on the West line of said Northeast  $\frac{1}{4}$  of the Southwest  $\frac{1}{4}$  that is 470 feet South of the Northwest corner thereof;  
thence West to the center of the slough;  
thence Southerly along the center of said slough to the South line of the North  $\frac{1}{2}$  of the Northwest  $\frac{1}{4}$  of the Southwest  $\frac{1}{4}$  of said subdivision;  
thence East to the point of beginning.

EXCEPT drainage ditch rights of way.

Situate in the City of Mount Vernon, County of Skagit, State of Washington.

### PARCEL "B":
