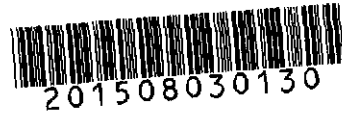

APPOINTMENT OF SUCCESSOR TRUSTEE




