Pursuant to RCW 9A.72.085, I certify under the penalty of perjury under the laws of the State of Washington that the following is true and correct:

I, Rick Rennebohm, make this declaration based upon my personal knowledge.

At some point in the past, G & R Investments, LLC became the owner of the following real property situated in the County of Skagit, State of Washington:

That portion of Government Lot 2, Section 5, Township 34 North, Range 2 East W. M. described as follows:

Beginning at the Intersection of the easterly line of the county road along the north and south centerline of said section 5 with the south line of the Anacortes-Mount Vernon Highway as it existed on November 4, 1949; thence southerly along the easterly line of the said county road 185 feet to the true point of beginning; thence southerly 165 feet along said line; thence easterly along a line perpendicular to the said easterly line of said county road 220 feet; thence northerly along a line parallel to the said easterly line of said county road 165 feet; thence westerly 220 feet to the true point of beginning.

The real property or its address is commonly known as 7656 State Route 20, Anacortes, WA 98221. The real property tax identification number is 340205-1-022-0007.

The above-described real property is hereinafter referred to as "The Real Property" At the time of the acquisition of The Real Property, the two members of G & R Investments, LLC were Rick Rennebohm and Gary S. Funk.

Through a mistake, G & R Investments, LLC did not renew its corporate license with the Washington Secretary of State, and the corporate license expired with an expiration date of 7/31/2010. Once I learned that the corporate license had expired for failure to pay the annual fee to the Washington Secretary of State, I tried to reincorporate under the name of G & R Investments, LLC, however, said name was taken at the time that I tried to reinstate the said LLC. The UBI number of G & R Investments, LLC was 601 968 812. I learned from the Secretary of State that I could reincorporate using the same UBI number under a similarly sounding name of the first LLC but not the exact same name. Thereafter, I reincorporated the said LLC under the name of "G& R Investments-XXX, LLC" under the new filing date of July 15, 2015 using the same UBI number of 601 968 812. Attached hereto as an exhibit is the corporation registration detail from the Washington Secretary of State's website printed on August 7, 2015 showing the reincorporation of the said LLC under the new name of G & R Investments-XXX, LLC. My name Rick Rennebohm is misspelled in the section entitled "governing persons" as "Fennebohm". The correct name for the member is "Rennebohm". The registered agent's name of Rick Rennebohm is correct together with the correct address on the said form.
