THE STATE OF WASHINGTON TO THE SHERIFF OF SKAGIT COUNTY GREETINGS:

WHEREAS, in the above-entitled court on July 21, 2015, Plaintiff, secured a judgment against defendants The Estate of Robert A. Dierst, Deceased, The Estate of Anne Garrett-Dierst, Deceased, Unknown Heirs and Devisees of Robert A. Dierst, and Unknown Heirs and Devisees of Anne Garrett-Dierst, in the total judgment amount of \$142,791.98, together with interest at a rate of \$15.7081 per diem from the date of judgment and continuing thereafter until the date of sale.

WHEREAS, 97 days elapsed from April 16, 2015 through the entry of judgment on July 21, 2015. Per diem interest in the amount of \$15.7081, multiplied by 97 days results in additional interest in the amount of \$1,523.69, which when added to the sum of \$142,791.98 results in a total judgment amount of \$144,315.67.
