

WHEREAS, in the above-entitled court on April 16, 2015, Plaintiff, secured a judgment against defendants DENNIS RIEGER, PERSONAL REPRESENTATIVE OF THE ESTATE OF DWARES RIEGER, DECEASED and UNKNOWN HEIRS AND DEVISEES OF DWARES REIGER, DECEASED, in the total judgment amount of \$230,988.10, together with interest at a rate of 4.00000% per annum, \$18.79 per diem from the date of judgment and continuing thereafter until the date of sale.
