

TERMINATION OF EASEMENT

THIS TERMINATION OF EASEMENT (this "<u>Termination</u>") is made and entered into effective as of <u>November</u>, 2015, by and between CTR PARTNERSHIP, L.P., a Delaware limited partnership ("<u>Grantee</u>"), and WELDTOWER INC., a Delaware corporation ("<u>Grantor</u>").

<u>RECITALS</u>:

- A. Lester O. Holte and Alvina G. Holte, husband and wife ("Prior Owners"), caused that certain plat titled Mira Vista, Inc. to be recorded on December 30, 1985 in the Official Records of Skagit County, Washington (the "Official Records") as Instrument No. 8512300041 (the "Plat").
- B. Grantee is the current owner of Doi 3 (as defined in the Plat); and Grantor is the current owner of Lot 2 (as defined in the Plat).
- C. As the owners of Lot 3 and Lot 2, Grantee and Grantor now desire to terminate that certain 20' utility easement encumbering Lot 2 and benefiting Lot 3 and more particularly described in the Plat (the "20' Utility Easement") in accordance with the terms and provisions set forth herein.

TERMINATION OF EASEMENT

NOW, THEREFORE, in consideration of the mutual covenants and conditions hereinafter set forth, the receipt and sufficiency of which are hereby acknowledged, Grantee and Grantor hereby terminate and release all of their right, title and interest in the 20' Utility Easement effective as of the date this Termination is recorded in the Official Records. Accordingly, no party shall have any further rights or obligations with respect to the 20' Utility Easement from and after the date of such recordation.
