LEASE AMENDMENT

AQUATIC LANDS LEASE AMENDMENT NO. 22-002579

THIS LEASE AMENDMENT is made by and between the STATE OF WASHINGTON, acting through the Department of Natural Resources ("State"), and JAMES and MARY LOU CAUDILL, a Marital Community (Tenant).

BACKGROUND

A. Lease No. 22-002579 was entered into on the 1st day of February 1986, by and between JAMES and MARY LOU CAUDILL (Tenant) and the STATE OF WASHINGTON, acting by and through the Department of Natural Resources.

The parties now desire to amend this Lease under the following terms and conditions:

THEREFORE, the parties agree as follows:

SECTION 1 AMENDMENTS

Section 1.1 of the Lease is amended to read as specified below.

1.1 <u>Term</u>. This lease shall commence on the 1st day of February 1986 and continue to the 1st day of February 2005.

SECTION 2 EFFECTIVE DATE

The amended provisions shall become effective as of 1st day of February 2005.

SECTION 3 NO RELEASE

State is not releasing any previous Assignor from fully performing the provisions of the Lease in effect at the time of such assignment or as otherwise agreed in writing between the State, previous Assignor, and the Tenant.

SECTION 4 WARRANTIES

Tenant represents and warrants to State that (i) the Lease is in full force and effect; (ii) Tenant is not in default or breach of the Lease; (iii) Tenant has no knowledge of any claims, offsets, or defenses of the Tenant under the Lease; and (iv) to the best of Tenant knowledge, the property is in full compliance with all applicable federal, state, and local governmental permits, rules, ordinances, and laws.

SECTION 5 CONFIRMATION OF LEASE

All other terms of the Lease not inconsistent with this Lease Amendment are hereby affirmed and ratified.

SECTION 6 RECORDATION

Tenant shall record this Lease or a memorandum documenting the existence of this Lease in the county in which the Property is located, at Tenant sole expense. The memorandum shall, at a minimum, contain the Property description, the names of the parties to the Lease, the State's lease number, and the duration of the Lease. Tenant shall provide State with recording information, including the date of recordation and file number. Tenant shall have thirty (30) days from the date of delivery of the final executed agreement to comply with the requirements of this subsection. If Tenant fails to record this Lease, State may record it and Tenant shall pay the costs of recording upon State's demand.
