**APPROVAL OF REVOCATION OF AMENDMENT NO. 2 TO COVENANTS,  
RESTRICTIONS AND EASEMENTS FOR SANDS SHORT PLAT (ANA 02-003)**

1. Castilleja Bluff Homeowners Association is a Washington nonprofit corporation whose members are owners of parcels of real estate ("Lots") within the Plat of Castilleja Bluff which Short Plat is recorded under Skagit County Recording No. 200512090181 (hereafter referred to as the "Castilleja Bluff Short Plat").
2. The Plat of Castilleja Bluff is located within and is part of the Sands Short Plat No. ANA 02-003, Anacortes, Washington which Short Plat is recorded under Skagit County Recording No. 200211220121 (hereafter referred to as the "Sands Short Plat").
3. The recorded Sands Short Plat refers, in part, to the Declaration of Covenants, Conditions, Restrictions and Easements for the Sands Short Plat recorded under Skagit County recording number 200211220122 (hereafter the "Sands Short Plat Declaration").
4. Section 1.4 of the Sands Short Plat Declaration states that each owner of each Lot is deemed to be a member of the Skyline Beach Club.
5. Certain owners of Lots in the Castilleja Bluff Plat (i.e. members of the Castilleja Bluff Homeowners Association) previously signed and arranged for the recording of a Second Amendment to the Sands Short Plat Declaration, which Second Amendment was recorded under Skagit County recording number 201308230003.
6. A Revocation of Second Amendment to Covenants, Restrictions and Easements for Sands Short Plat (ANA 02-003) was approved by a majority of the Board of Directors of the Castilleja Bluff Homeowners Association and by not less than seventy five percent (75%) of all Lot Owners.
7. The Second Amendment to the Sands Short Plat Declaration, which Second Amendment was recorded under Skagit County recording number 201308230003, was revoked by the recording of a written Revocation, a copy of which is attached (the "Revocation").
8. The undersigned are the Owners of the following tax parcels located within Castilleja Bluff:

9. The undersigned previously did not vote in favor of or otherwise approve the terms and conditions of the Revocation. However, the undersigned now approve

and agree to be fully and completely bound by the terms and conditions of the Revocation.

10. This Approval shall be and is binding on the undersigned and all of their successors, heirs, beneficiaries, purchasers and assigns.

11. This document may be recorded at the discretion of either Castilleja Bluff Owners Association or Skyline Beach Club, Inc.
