NAVIGABLE NOTE: THE GENERAL LAND OFFICE MEANDERED CAMPBELL LAKE IN AUGUST 1871, AND DEEMED THE LAKE AS A NAVIGABLE BODY OF WATER, HOWEVER WASHINGTON STATE OR THE COURTS HAVE NOT DETERMINED THE NAVIGABLE STATUS OF SECOND CLASS SHORELANDS WITHIN LAKE CAMPBELL.

A WASHINGTON STATE SUPREME COURT CASE NUMBER 13659, LITKA V. CITY OF ANACORTES DECLARED CAMPBELL LAKE TO BE NOT NAVIGABLE. THE COURT OPINION WAS ONLY SUPPORTING THE VERDICT FOR A GRANT OF RELIEF FOR DAMAGES TO LITKA BY THE CITY OF ANACORTES. THIS CASE WAS NOT A QUIET TITLE CASE AND ALL PARTIES WITH OWNERSHIP ON THE LAKE WERE NOT NAMED, INCLUDING THE STATE, THEREFORE THE TITLE OF THE PRIVATE SHORELANDS AND THE PUBLIC BEDLANDS WERE NOT SUBJECT TO THE VERDICT OF THE COURT.

THE AREA AND EXTENTS OF THE SECOND-CLASS SHORE LANDS HAS NOT PROVIDED SINCE A LINE OF NAVIGABILITY HAS NOT BEEN ESTABLISHED FOR CAMPBELL LAKE. FOR GRAPHICAL PURPOSES, A DASHED LINE HAS BEEN DRAWN AT THE TWO-FOOT DEPTH OF WATER, AS OBSERVED JULY 26, 2010, TO SHOW THE APPROXIMATE SHAPE OF THE PARCEL.

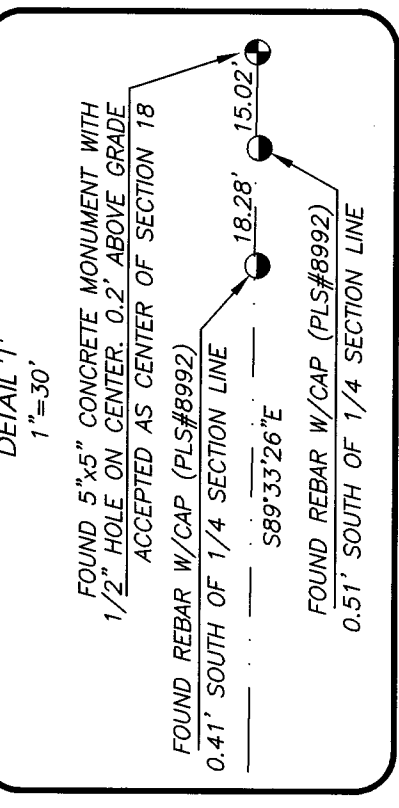
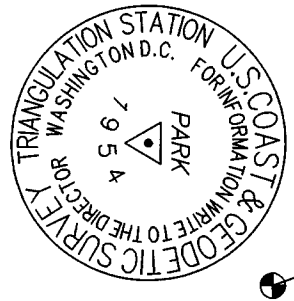
