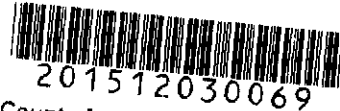


Original Trustee(s) by the terms of said Deed of Trust and by applicable law.
