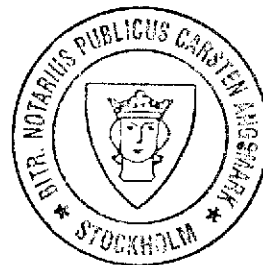

### ASSIGNMENT OF SECURED PROMISSORY NOTE & DEED OF TRUST

of the Note and all collateral securing the repayment of the Note as described in the Deed of Trust, and in case of payment to discharge the same as fully as Assignor might or could do.

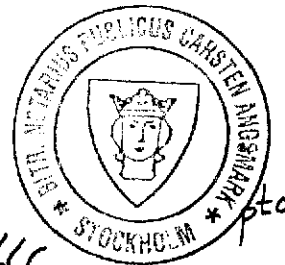

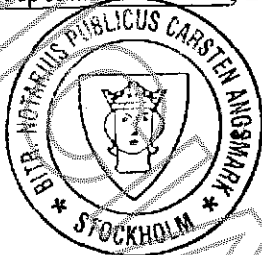

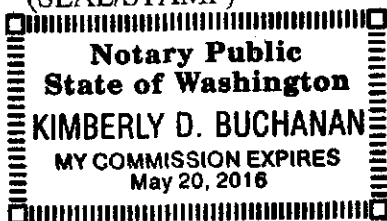
